User agreement

on the terms of use of the Website <https://evrionta.ru/ru> and the Evrionta mobile application

1. Subject of the Agreement

1.1. This User Agreement (hereinafter — the Agreement) governs the relationship between LLC “Toscana Food” (hereinafter — the Administration) and the User arising from the use of the Website, the Evrionta mobile application, and their services (including the AI assistant and the generation of personalized protocols).

1.2. Any use of the Website and application in any manner constitutes the User’s full and unconditional acceptance of the terms of this Agreement.

2. Website and Application Functionality

2.1. The Administration provides the User with the ability to:

- browse the Evrionta product catalog;
- use the AI assistant to generate personalized recommendation protocols;
- place orders for the purchase of products;
- receive informational support.

3. Terms of Use of the AI Assistant and Recommendation Technologies

3.1. The AI assistant provides the User with personalized recommendations on the use of Evrionta products based on data entered by the User.

3.2. Limitation of liability: The User acknowledges that they have been informed of, and accept, that the Administration is not a medical organization, does not hold a medical license, does not make diagnoses, and does not prescribe treatment. The recommendations of the AI assistant are for informational purposes only.

3.3. The User agrees to consult a physician before beginning the use of any products if they have chronic conditions, are taking medications, are pregnant, or are breastfeeding.

3.4. The User bears full responsibility for the accuracy of the health data they provide to the AI assistant. The Administration does not verify such data and is not liable for the consequences of inaccurate recommendations resulting from incorrect source data.

4. Intellectual Property

4.1. All materials published on the Website and in the application (texts, images, design, source code, protocols, databases) are intellectual property of the Administration and are protected under the legislation of the Russian Federation.

4.2. The User may not copy, reproduce, or distribute the materials of the Website without the written permission of the Administration.

5. Liability

5.1. The Administration is not liable for losses incurred by the User as a result of using (or being unable to use) the Website and application, except in cases provided for by the legislation of the Russian Federation.

5.2. The Administration is not liable for temporary disruptions to the operation of the Website caused by technical failures on the part of the hosting provider or the actions of third parties.

6. Final Provisions

6.1. The Administration reserves the right to amend this Agreement unilaterally without prior notice to the User.

6.2. All disputes shall be resolved in court at the location of the Administration in accordance with the legislation of the Russian Federation.
